

Ltd., Betterways Finance & Leasing Private Limited, Lotte Trading & Allied Services Private Limited, Lotus Finance & Investments Private Limited, Midopa Holdings Private Limited, Xonix Enterprises Private Limited were part of 'Promoter and Promoters Group' of DCM Limited. All these companies collectively held 90,30,495 equity shares of DCM Limited in their respective 14 different demat accounts. However pursuant to sanction of a Scheme of Amalgamation ('Scheme') by Hon'ble Delhi High Court and its becoming effective from August 26, 2016, Betterways Finance & Leasing Private Limited, Lotte Trading & Allied Services Private Limited, Lotus Finance & Investments Private Limited, Midopa Holdings Private Limited, Xonix Enterprises Private Limited (collectively referred as 'transferor companies') have been merged into and with Aggresar Leasing & Finance Pvt. Ltd. ('transferee company') and all the assets and liabilities and entire businesses of 'transferor companies' have been transferred/vested into the transferee Company and the said transferor companies ceased to exist from the said effective date. Due to same, aforesaid 90,30,495 equity shares of DCM Limited held by all these companies have been shown here as held only by transferee company (i.e. Aggresar Leasing & Finance Pvt. Ltd.) under heading Promoters and Promoter Group.

Further, equity shares of DCM Limited held by Aggresar Leasing & Finance Limited has been transferred to Crescita Enterprises Private Limited on 23rd March, 2017 by way of gift, for nil consideration, as inter-se transfer of shares amongst qualifying persons as specified under Regulation 10(1)(a)(iii) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011.
